These considerations have led to the new company form (conversion of a limited liability company to a stock corporation) with a new company name and associated logo.

Our logo and name are our programme

In designing the logo we had the symbol of a protective helmet in mind. The helmet has been a symbol of safety ever since ancient times. It protects an important part of the body, namely the head, as a kind of “switchboard”. In today’s world of work there is even an obligation to wear a helmet in especially hazardous areas. Just as the helmet protected not only one’s head but also one’s neck and face in ancient times, so it is that for us the helmet is a symbol of protecting people, products and companies.
